SUBJECT: REQUEST FOR QUOTATIONS FOR PRODUCTION OF BRANDED VISIBILITY MATERIALS

Dexis Interactive Incorporated, Washington, Chisinau branch invites your firm to participate in this competitive solicitation for pricing, delivery, and terms of potential sale of **branded visibility materials**. Dexis reserves the right to reject any and all offers, to add, delete, or modify any element of the solicitation at any time without prior notification and without any liability or obligation of any kind. This RFQ does not oblige Dexis to enter into a contract nor does it oblige Dexis to pay any costs incurred in the preparation of submission of any Response.

Dexis anticipates that this Request for Quotation (RFQ) will result in a Blanket Purchase Agreement (agreement) or possibly multiple agreements — to establish specific pricing levels and parameters for ordering these services.

Offerors are responsible for ensuring that their offers are received by Dexis in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere with instructions described in this RFQ may lead to disqualification of an offer from consideration.

BACKGROUND

Dexis Consulting Group is a for-profit company founded in 2001 to strengthen management systems for the U.S. Government across developing economies. Dexis provides monitoring and evaluation, program management, institutional support, project implementation, and training solutions to address some of the world's greatest challenges.

Dexis is currently implementing multiple US government funded projects in the Republic of Moldova. Our Moldovan projects focus on rule of law, justice sector reform and anti-corruption activities to support Moldovan citizens access to justice, improve services and the institutional capacity of justice sector agencies to serve all citizens.

As part of implementation of projects activities, Dexis requires the purchase of as-needed branded visibility materials in support of planned activities.

DESCRIPTION OF SERVICES

The purpose of this RFQ is to engage the service provider to produce branded visibility materials for Dexis projects.

At this time, specific quantities to be purchased under any agreement resulting from this RFQ are unknown. Specific quantities will depend on the needs of the projects. Individual requests will be issued under the agreement, as the need arises for additional services. Prices must be presented in Moldovan Lei (MDL). Offers must remain valid for not less than sixty (60) calendar days after the offer deadline. The offered rates must remain fixed throughout the term of the Agreement.

Offerors are required to submit their quotations by using the template provided in Annex 2 and submit a signed/stamped version to Dexis.

REQUIREMENTS

All services offered in response to this RFQ or supplied under any resulting award must meet **USAID Geographic Code 935** in accordance with the United States Code of Federal Regulations (CFR), 22 CFR §228. The cooperating country for this RFQ is Republic of Moldova.

Offerors may not offer or supply services or any commodities that are manufactured or assembled in, shipped from, transported through, or otherwise involving any of the following countries: Cuba, Iran, North Korea, Syria.

Any and all items that are made by Huawei Technology Company, ZTE Corporation, Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, Dahua Technology Company will not be accepted. If quotes include items from these entities, please note that they will be deemed not technically responsive and excluded from competition.

By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the U.S. Government. Dexis will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government.

All responses must be in English. Offerors must submit the following in order to be considered responsive and eligible for award:

- Cover letter (Annex 1) *, signed by an authorized representative of the offeror, which contains
 general information about the contractor, including full legal name and address of the company,
 full name of the legal representative of the company, a contact name, email address, and
 telephone number to facilitate communication between Dexis and the prospective contractor.
- 2. Company profile one page summary indicating a brief history of the company, **demonstrating at least 5 years of previous experience** in the provision of branded visibility materials.
- 3. Quotation Submission Form (Annex 2) *. The agreement under which this procurement is financed does not permit the financing of any taxes, VAT, tariffs, duties, or other levies imposed by any laws in effect in the Cooperating Country (Republic of Moldova). No such Cooperating Country taxes, VAT, charges, tariffs, duties, or levies will be paid under an order resulting from this RFQ. Dexis will provide the selected offeror with the VAT exemption letters.
- 4. Copy of offeror's registration documents: Extract from the state register of legal entities (Extras din Registrul de stat al persoanelor juridice). Prospective contractor must be **legally registered under the laws of the Republic of Moldova.**
- 5. A minimum of three references letters indicating the relevant services carried out that best illustrate organization qualifications and past performance. References from USAID or similar donor-funded projects are preferred. Independent verification of the references may be carried out.

- 7. Copy of offeror's bank details information
- 8. Unique Entity Identifier (UEI), if applicable. Companies or organizations, whether for-profit or non-profit, shall be requested to provide a Unique Entity Identifier (UEI) number if selected to receive an award in response to this RFQ valued greater than or equal to USD\$30,000 (or equivalent in other currency). If the Offeror does not have a UEI number and is unable to obtain one before the submission deadline, Offeror shall include a statement noting their intention to obtain a UEI number should it be selected as the successful offeror or explaining why registration for a UEI number is not possible. Contact sam.gov to obtain a number. Further guidance on obtaining a UEI number is available from Dexis upon request. By submitting this quotation, the offeror agrees to comply with this requirement as applicable if selected.
- 9. Subcontractor/Vendor UEI and Executive Compensation Self-Certification, if applicable. This form shall be completed only if the value is over \$30,000 and will be required before the agreement signature. By submitting this quotation, the offeror agrees to comply with this requirement as applicable if selected.
- 10. If a government, its agents, or agencies, have an ownership or managerial interest in the company, the prospective contractor must indicate this when submitting its offer. Failure to do so will result in the prospective contractor's offer being removed from consideration.
- 11. The Offeror must agree to keep the bid valid for a minimum of 60 calendar days.
- 12. The prices must be valid for the entire duration of the contract.

EVALUATION

Offerors applying will be evaluated based on the minimum technical requirements presented below:

- Legally registered under the laws of the Republic of Moldova.

- At least 5 years of demonstrated previous experience in the provision of branded visibility materials.
- **A minimum of three references letters** that best illustrate organization qualifications and past performance.

The agreement(s) will be awarded to the **lowest price technically compliant offer**(s).

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed "non-responsive" and thereby disqualified from consideration. Dexis reserves the right to waive immaterial deficiencies at its discretion.

Best-offer quotations are requested. It is anticipated that the award will be made solely on the basis of these original quotations. However, Dexis reserves the right to conduct any of the following:

- Dexis may conduct negotiations with and/or request clarifications from any offeror prior to award.
- While preference will be given to offerors who can address the full technical requirements of this RFQ, Dexis may issue a partial award or split the award among various Vendors, if in the best interest of the Projects.

Please note that in submitting a response to this RFQ, the offeror understands that USAID/INL is not a party to this solicitation and the offeror agrees that any protest hereunder must be presented—in writing with full explanations—to Dexis for consideration, as USAID/INL will not consider protests regarding procurements carried out by implementing partners. Dexis, at its sole discretion, will make a final decision on the protest for this procurement.
