Dexis invites your firm to participate in this competitive solicitation for pricing, delivery, and terms of potential sale of **furniture for the Straseni**, **Criuleni**, **Hincesti and Drochia Pilot Model Courts (PMCs)**. Dexis reserves the right to reject any and all offers, to add, delete, or modify any element of the solicitation at any time without prior notification and without any liability or obligation of any kind. This RFQ does not oblige Dexis to enter into a contract nor does it oblige Dexis to pay any costs incurred in the preparation of submission of any Response.

Dexis anticipates that this Request for Quotation (RFQ) will result in a **Purchase Order** (agreement/s) for the supply, delivery and installation of furniture for Straseni, Criuleni, Hincesti and Drochia Pilot Model Courts (PMCs).

BACKGROUND

Dexis Consulting Group is a for-profit company founded in 2001 to strengthen management systems for the U.S. Government across developing economies. Dexis provides monitoring and evaluation, program management, institutional support, project implementation, and training solutions to address some of the world's greatest challenges.

Dexis is currently implementing the USAID-funded Model Court Initiative in Moldova (MCI). The goal of the MCI is to assist the Government of Moldova to improve the performance of courts in delivering quality justice services and to improve the connection between courts, communities, and system users.

MCI works toward two Objectives:

- 1) selected Moldovan courts identified and supported through targeted assistance to improve functioning and services to gain Model Court status, and
- supplementary national level assistance provided in key areas necessary for changes to enhance court improvement at the individual level, including but not limited to support to the newly created Superior Council of Magistracy, the new Supreme Court of Justice, and other key legal actors in Moldova.

In carrying out its activities, MCI collaborates with key actors and stakeholders in the Moldovan justice system, primarily the Superior Council of Magistracy (SCM), the Ministry of Justice (MOJ), the Agency for Court Administration (ACA), the National Institute of Justice (NIJ), as well as the courts throughout the country. The MCI's activities are led by a team of experienced national legal and IT experts with in-depth knowledge of the Moldovan judicial system.

DESCRIPTION OF GOODS/SERVICES

With this RFQ, Dexis is soliciting offers from qualified companies for the supply, delivery and installation of furniture for Straseni, Criuleni, Hincesti and Drochia Pilot Model Courts (PMCs), as part of its activities, in accordance with the specifications.

Offerors are required to submit their quotations by using the template provided in the "Annex 2: Quotation Submission Form".

Warranty: Full warranty service and repair within the cooperating country is required for all commodities under this RFQ. At the time that any commodity is transferred to another entity within the cooperating country, all rights to warranty support and service shall be transferred with the commodity to that entity's end-user.

After-sale service: The ability to provide timely and complete after-sale services.

REQUIREMENTS

All services offered in response to this RFQ or supplied under any resulting award must meet **USAID Geographic Code 935** in accordance with the United States Code of Federal Regulations (CFR), 22 CFR §228. The cooperating country for this RFQ is Republic of Moldova.

Offerors may not offer or supply services or any commodities that are manufactured or assembled in, shipped from, transported through, or otherwise involving any of the following countries: Cuba, Iran, North Korea, Syria.

Any and all items that are made by Huawei Technology Company, ZTE Corporation, Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, Dahua Technology Company will not be accepted. If quotes include items from these entities, please note that they will be deemed not technically responsive and excluded from competition.

By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the U.S. Government. Dexis will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government.

All responses must be in English. Offerors must submit the following in order to be considered responsive and eligible for award:

- 1. A contact name, email address, and telephone number to facilitate communication between Dexis and the prospective contractor.
- 2. General information about the contractor's history and experience.
- Copy of offeror's registration documents: Extract (Extras din Registrul de stat al persoanelor juridice). Prospective contractor must be legally registered under the laws of the Republic of Moldova.

- 4. **Statement of satisfactory performance** (Certificates/ Letters) from the top three (3) clients in terms of Contract value in similar field.
- 5. Evidence of Responsibility (Annex 1) *.
- 6. Quotation Submission Form (Annex 2) *.
- 7. Unique Entity Identifier (UEI), if applicable. Companies or organizations, whether for-profit or non-profit, shall be requested to provide a Unique Entity Identifier (UEI) number if selected to receive an award in response to this RFQ valued greater than or equal to USD\$30,000 (or equivalent in other currency). If the Offeror does not have a UEI number and is unable to obtain one before the submission deadline, Offeror shall include a statement noting their intention to obtain a UEI number should it be selected as the successful offeror or explaining why registration for a UEI number is not possible. Contact sam.gov to obtain a number. Further guidance on obtaining a UEI number is available from Dexis upon request. By submitting this quotation, the offeror agrees to comply with this requirement as applicable if selected.
- 8. **Subcontractor/Vendor UEI and Executive Compensation Self-Certification,** if applicable. This form shall be completed only if the value is over \$30,000 and will be required before the agreement signature. By submitting this quotation, the offeror agrees to comply with this requirement as applicable if selected.
- 9. **Vendor Source and Nationality Statement,** if applicable. For all procurements of commodities at or above \$25,000 under USAID-funded contracts, vendors must complete and sign the statement before the agreement signature.
- 10. If a government, its agents, or agencies, have an ownership or managerial interest in the company, the prospective contractor must indicate this when submitting its offer. Failure to do so will result in the prospective contractor's offer being removed from consideration.
- 11. The Offeror must agree to keep the bid valid for a minimum of **90 calendar days** from the deadline for the submission of quotation. The prices must be valid for the entire duration of the contract.
- 12. The furniture presented in the quotation must be available for delivery and installation within 6 (six) months upon contract signature.

*All the Annexes (1-2) must be dully completed and signed and submitted as separate documents.

EVALUATION

All Responses must contain the elements outlined in this RFQ for Dexis to comprehensively evaluate each quotation.

Dexis will first evaluate quotations for compliance with the mandatory requirements/ elements of this RFQ. Quotations that do not contain all mandatory requirements/ elements may not be considered.

Offerors are responsible for ensuring that their offers are received by Dexis in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere with instructions described in this RFQ may lead to disqualification of an offer from consideration.

Offerors applying will be evaluated based on the minimum requirements below:

- Officially registered legal entity with full capacity to act under the laws of the Republic of Moldova and possess all licenses, permits and government approvals necessary for performance of the work.
- Minimum 5-year of successful work experience in furniture manufacturing and installation on the Moldovan market;
- Statement of satisfactory performance (Certificates/ Letters) from the top three (3) clients in terms of Contract value in similar field;

The agreement(s) will be awarded to the lowest price technically compliant offer(s).
