Dexis Consulting Group requests quotations for pricing and terms of provision of printing services, as outlined below:

BACKGROUND AND CONTEXT

Dexis Consulting Group (Dexis), an international consulting company based in USA, is currently implementing the USAID-funded **Model Court Initiative (MCI) project in Moldova**. The goal of the MCI project is to assist the Government of Moldova to implement initiatives aimed at improving the efficiency, performance, and quality of court services based on best international practices and in line with international excellence standards for court services.

INSTRUCTIONS TO OFFERORS

With this RFQ, Dexis is soliciting offers from qualified companies to provide **high quality printing services of five legal literacy communication materials and to distribute the printed materials to 24 locations across the country** in accordance with the specifications set forth below.

Offerors are responsible for ensuring that their offers are received by Dexis in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere with instructions described in this RFQ may lead to disqualification of an offer from consideration.

Offer Submission Deadline

Offers must be received no later than November 30, 2022, 17:00 local time. Proposals received after the deadline may not be considered.

Submission of Offers

All offers must be submitted electronically to the following email address: moldova@dexisonline.com, mentioning the title Printing Services (RFQ # 2004-03-009) in the subject line.

Offers must be on company letterhead with the company's contact name and address. Any email that does not contain the mentioned title will be automatically discarded.

Questions and Clarifications

All questions and clarifications regarding this RFQ must be submitted in writing to moldova@dexisonline.com no later than November 27, 2022, 17:00 local time. All correspondence must provide reference to the RFQ number. Questions and clarifications that may be of interest to other bidders, will be circulated to all parties that submitted the questions.

Only the written answers issued by Dexis will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of Dexis or

any other entity should not be considered as an official response to any questions regarding this RFQ.

Required Documentation

The offers must include the following:

- Cover letter, signed by an authorized representative of the offeror, which contains general information about the contractor, including full legal name and address of the company, full name of the legal representative (president or managing director) of the company, a contact name, email address, and telephone number to facilitate communication between Dexis and the prospective contractor.
- Company CV in Romanian or English to highlight the previous experience, including a description of the company's capacity to provide high quality printing products in terms of technical equipment and human resources.
- Copy of company registration documents.
- Financial Proposal (in the format see table below with TECHNICAL REQUIREMENTS).
- Three recommendation letters or three references (contact name, phone number and email address).
- A letter that will include the company's commitment to complete the work within a maximum of 45 working days after the contract signing.
- Samples of previous works (photographs) that were printed by the company in the last year in accordance with the formats requested in this RFQ.

Offerors are requested to provide quotations on their official quotation format or letterhead.

Source/Nationality/Origin

Only firms legally registered in Moldova may submit an offer in response to this RFQ. All services offered in response to this RFQ or supplied under any resulting award must meet USAID Geographic Code 937 and 110 in accordance with the United States Code of Federal Regulations (CFR), 22 CFR §228. The cooperating country for this RFQ is Moldova.

Quotations

Prices must be quoted as showing unit prices and total prices with VAT 0%. No taxes or fees are to be added. Quotations must be expressed as fixed price, in MDL.

Validity Period

Offers must be valid for a minimum of sixty (60) calendar days after the offer deadline.

Eligibility

By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the U.S. Government. Dexis will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government.

Negotiations

It is expected that awards will be made based on submitted offers. However, Dexis reserves the right to conduct negotiations and request clarifications prior to awarding the contract.

Basis for Award

The award will be made to an offeror whose offer is compliant with RFQ instructions and is evaluated as the most advantageous for Dexis.

Terms and Conditions

The award is subject to Dexis standard terms and conditions. Please note that Dexis standard payment terms are ten (10) banking business days upon receipt of the complete documentation after acceptance of the deliverables. No advance payments are possible.

Delivery Timeframe

The bidder should specify the timeframe for delivery of the requested printing materials, expressed in calendar days (after receiving the order). Delivery should be within a **maximum of 45 working days after contract signature**.

A letter that will include the company's commitment to complete the work within a maximum of 45 working days after the contract signing.

Eligibility Criteria

1. Officially registered legal entity as per Republic of Moldova's regulations with full capacity to act
2. At least five years of work-related experience in printing services and demonstrated knowledge of pre-press processes
3. Proven specialized experience in printing products similar to those listed in this request
4. Demonstrated availability of technical and human resources for successful implementation of the assignments
5. An asset will be considered previous experience in working with USAID Mission in Moldova or USAID funded projects as well as international organizations or projects, human rights or justice sector NGOs, justice sector institutions.

Evaluation of Quotations

Dexis will first evaluate quotations for compliance with the mandatory requirements/elements of this RFQ. Quotations that do not contain all mandatory requirements will not be considered.

Evaluation of offers will be performed according to the following evaluation criteria:
